### Our Experience



- Building on existing partnership between HACEP/UTEP/Paso del Norte Health Foundation
- Aligned with local priorities, HUD recommendations, HACEP mission, health equity
- Involved youth in policy advocacy; local tobacco control network prioritizing policy expansion (strengthening local ordinances, tobacco-free campuses, more counties/municipalities, more multiunit housing)

### Implementation Barriers



- Equitable enforcement among property managers
- · Length of time to address complaints
- "It's my home, I can do what I want"
- Misconception that smoking is a "right"
- Limited access or availability of resources
- Cessation/ Healthcare/ Transportation

Expanding policies to inlcude Low-Income Housing Tax Credit & non-subsidized apartments



- Conducted interviews at two smoke-free communities to identify challenges and best practices
- Interviewed four property managers, four residents and five maintenance staff

Feedback from Property Manager at Smoke-Free Elderly Community...



- Residents resisting change...some still smoking inside apartments
- "Elderly residents have a harder time adapting to change"
- Although residents signed a lease addendum agreeing to not smoke inside the building, they violate it.

# Feedback from Property Manager at Smoke-Free Elderly Community...



- Non-smoking residents insist smoke from one apartment travels to the next one
- "Enforcement is time consuming and currently eligibility certifications are a priority"
- Property management will be stricter in enforcing lease due to new management style that will be followed

### Feedback from Residents at Smoke-Free Communities...



- "I smell smoke coming through my vent from my neighbor"
- "It bothers me and I don't understand why they are not evicted for not following lease"

- Property manager sees visible differences from a smoke-free community to a smoking one, for instance:
  - Smoking community is filthy and cigarette butts are found in the common grounds and inside
  - Smoke-free community is cleaner and prettier in the common grounds

# Feedback from Property Manager at Smoke-Free Multifamily Community..."



- Property manager sees visible differences from a smoke-free community to a smoking one, for instance:
  - Smoking community walls and blinds inside apartments are yellow and stinky
  - Smoke-free community walls maintain their original color and free of smoke odors

# Feedback from Maintenance Staff at Smoke-Free Multifamily Community...

- Mentioned some apartments reek of smoke so assumption is that residents continue to smoke inside apartment
- During interview did not want to be recorded or provide their names

### Partnerships to support PHA's



- Identify internal partners at PHAs
  - Link tobacco education and cessation to community programs offered at PHAs
- Collaborate with existing partners to offer multiple quit smoking opportunities
  - DSHS regional offices
  - Community health centers
  - Mental health community centers
  - Women, Infants and Children Program
  - Public Housing Authorities that have smoke-free policies
- · Diversify group of people trained to refer to quitline
  - More occupations/roles represented
